- Send you text messages and push notifications.
- Prevent fraud and enhance the security of the App.
- Conduct analytics and research concerning your use of the App.
- Comply with legal obligations and enforce our terms and conditions.

Sharing Your Information

We may share the information we collect about you in the following ways:

With Service Providers

We may share your information with third-party vendors, service providers, contractors, or agents who perform services on our behalf, such as payment processing, data analysis, email delivery, hosting services, customer service, and marketing assistance.

For Business Transfers
